6. County Cllr.& District Report:

No go on a mini-island at the junction of Arrow Lane/Evesham Road.

Evesham Street – Mark has reported the request for it to be changed to Evesham Road.

Reserved Sites: This is due to go through cabinet shortly – we are obliged to have reserved sites for overspill in the event of losing 5YHLS.

Transformation programme about “right-sizing”. This is all about the funding levels expected from Government Grants have already fallen and not sure what the future will bring.

Cherry Trees Care Home: subject of an investigation by the CQC over allegations of abuse of residents.

Climate emergency: this will have an impact on all residents of the district, Will affect SDC policy decisions.

Rural Broadband: Sill exploring this issue, currently working with BDUK.

Croft Lane Power Station: As of 9/9/19 the applicants are awaiting Highways England’s response to the application.

A46 update: The SUA2 scheme is with the planning department.

.Binton/Billesley cross roads- a meeting with the developers who have provided supporting evidence of their scheme. Mark taking advise on how to maintain his opposition to the scheme.
